
#### How do I vote by post?





Original voting envelope open here


Fill out the voting paper

Sign your voting identity card (not in all cantons)

Put the small voting envelope and the voting identity card in the original voting envelope. The return address must be visible through the window



Post the envelope to the local town hall by 21 September 2020 or deposit it personally in the mailbox of the local town hall by the 25th of September
